

Speaker Biographies

ADMIRAL DENNIS C. BLAIR, U.S. NAVY (RET.) served as Director of National Intelligence from January 2009 to May 2010. He led sixteen national intelligence agencies, administering a budget of \$50 billion and providing integrated intelligence support to the President, Congress and operations in the field. Prior to rejoining the government, he held the John M. Shalikashvili Chair in National Security Studies with The National Bureau of Asian Research, served as deputy director of the Project for National Security Reform, and as a member of the Energy Security Leadership Council of Securing America's Future Energy.

From 2003 to 2006, Admiral Blair was President and Chief Executive Officer of the Institute for Defense Analyses (IDA), a federally funded research and development center based in Alexandria, Virginia that supports the Department of Defense, the Department of Homeland Security and the Intelligence Community. He has been a director of two public companies, EDO and Tyco International, and served on the boards of many non-profit organizations.

Prior to retiring from the Navy in 2002, Admiral Blair served as Commander in Chief, U.S. Pacific Command, the largest of the combatant commands. During his 34-year Navy career, Admiral Blair served on guided missile destroyers in both the Atlantic and Pacific fleets and commanded the Kitty Hawk Battle Group. Ashore, he served as Director of the Joint Staff and held budget and policy positions on the National Security Council and several major Navy staffs.

A graduate of the U.S. Naval Academy, Admiral Blair earned a master's degree in history and languages from Oxford University as a Rhodes Scholar, and was a White House fellow at the Department of Housing and Urban Development. He has been awarded four Defense Distinguished Service medals, three National Intelligence Distinguished Service medals, and has received decorations from the governments of Japan, Thailand, Korea, Australia, the Philippines and Taiwan.

JUNKO CHANO is the Executive Director for Programs at the Sasakawa Peace Foundation (SPF) and the President of SPF USA. Prior to joining the SPF, Ms. Chano worked at several foundations including the Japan Foundation, Philadelphia Foundation, and the Ford Foundation's New York Office. At the Ford Foundation, she helped strengthening the capacity of community foundations that emerged around the globe. She later joined the Office of the Organizational Services of the Ford Foundation and developed a series of GrantCraft videos that would enhance critical thinking of grant makers for their program development activities. Ms. Chano graduated from Hitotsubashi University in Tokyo with a degree in Social Sciences. She also received her Masters of Government Administration from the University of Pennsylvania.

SHINJI FUJINO is Director General of Business Strategy Department, Oil & Gas Upstream Business Unit at Japan Oil, Gas and Metals National Corporation (JOGMEC), where he supports Japanese industries in developing oil and gas resources overseas through financial, technical and diplomatic measures. Mr. Fujino entered the Ministry of Economy, Trade and Industries (METI), the Government of Japan in 1987. He has over ten years of experience in energy policy in METI. Additionally, Mr. Fujino worked in the International Energy Agency (IEA, Paris) from September 2008 to June 2012. As Head of Country Studies Division, he reviewed energy policies of the IEA member countries. He majored in physics, and has a BA and a MS from the University of Tokyo.

MIKKAL E. HERBERG is Research Director of NBR's Energy Security Program. He is also a senior lecturer on international and Asian energy at the Graduate School of International Relations and Pacific Studies, University of California, San Diego.

Previously, Mr. Herberg spent 20 years in the oil industry in Strategic Planning roles for ARCO, where from 1997 to 2000 was Director for Global Energy and Economics, responsible for worldwide energy, economic, and political analysis. He also headed country risk analysis, responsible for advising the executive management on risk conditions and investment strategies in countries and regions where ARCO had major investments. His previous positions with ARCO included Director of Portfolio Risk Management and Director for Emerging Markets.

Mr. Herberg writes and speaks extensively on Asian energy issues to the energy industry, governments, and major research institutions in the Asia-Pacific region and Europe, including the United States, China, and Japan. He is cited frequently in the media, including *The Wall Street Journal*, *The Washington Post*, *South China Morning Post*, *Asahi Shimbun*, *Reuters*, *NIKKEI News*, *Caijing*, and National Public Radio.

ROY KAMPHAUSEN is Senior Advisor for Political and Security Affairs (PSA) at NBR. Mr. Kamphausen previously served as Senior Vice President for PSA and Director of NBR's Washington, D.C., office.

Prior to joining NBR, Mr. Kamphausen served as a U.S. Army officer. As a China Foreign Area Officer, his career included assignments as China policy director in the Office of the Secretary of Defense, China strategist for the Chairman of the Joint Chiefs, and serving as a military attaché at the U.S. Embassy in Beijing.

Mr. Kamphausen's areas of professional expertise include China's People's Liberation Army (PLA), U.S.-China defense relations, U.S. defense and security policy toward Asia, and East Asian security issues. He has presented lectures on these topics throughout the United States, Asia and Europe.

Mr. Kamphausen's NBR publications include the last seven volumes from the annual PLA Conference, published by the U.S. Army War College, including *The PLA Learns by Doing: Exercises from 2008-2012* (co-edited with David Lai and Travis Tanner, January 2013). He also authored "China's Land Forces: New Priorities and Capabilities" in *Strategic Asia 2012-13: China's Military Challenge* (edited by Ashley Tellis and Travis Tanner, October 2012). Mr. Kamphausen was deputy director of the IP Commission in 2012 and an author of the Commission's *Report on the Theft of American Intellectual Property*.

Mr. Kamphausen is an Adjunct Associate Professor at Columbia University's School of International and Public Affairs, and is a regular lecturer at leading U.S. military institutions, including the United States Military Academy (West Point), the National Defense University, and Army War College. He testifies regularly before Congress and consults with the U.S. Department of Defense. His analysis appears regularly in major international media, including *Foreign Policy*, *Financial Times*, *New York Times*, National Public Radio, *Newsweek*, and others.

Mr. Kamphausen holds a BA in Political Science from Wheaton College and an MA in International Affairs from Columbia University. He studied Chinese at both the Defense Language Institute and Beijing's Capital Normal University. He is a member of the National Committee on U.S.-China Relations, the Asia Society, and the Council for Security and Cooperation in the Asia-Pacific.

J. JAMES KIM is a Research Fellow at the Asan Institute for Policy Studies and a lecturer in the Executive Master of Public Policy and Administration program at Columbia University. Previously, he was an Assistant Professor of Political Science at the California State Polytechnic University (Pomona). He has also served as a summer research associate at the RAND Corporation and as a statistical consultant for the Institute for Social and Economic Research and Planning at the School of International and Public Affairs in economy, energy, security, public opinion, democracy, methodology, and media.

Dr. Kim holds a Doctorate in political science from Columbia University as well as a bachelors and masters in Industrial and Labor Relations from Cornell University.

KEN KOYAMA is Chief Economist and Managing Director at the Institute of Energy Economics, Japan (IEEJ). He also takes a position of Professor at Graduate School of Public Policy at the University of Tokyo since 2010. Dr. Koyama joined IEEJ in 1986 as Economist in the Oil Group. Since then, he had various careers at IEEJ including Senior Economist in the World Oil & Energy Group (1992); Head of the World Oil & Energy Group (1997); and Senior Research Fellow, Energy Strategy Unit (2005). He has a BA in Economics from Waseda University; an MA in Economics from Waseda University; and a PhD from University of Dundee in Scotland. His PhD thesis is: *Japan's Energy Strategies Towards The Middle East*.

Dr. Koyama's specialized field of research includes energy security issues and geopolitics of energy; and analysis for global energy market and policy development with emphasis on the Asia-Pacific region. He has served as a committee member of energy policy related councils and advisory committees of the Japanese government on many occasions.

MEREDITH MILLER is Senior Vice President of Trade, Economic, and Energy Affairs & Outreach and Director of the Washington, D.C., office at NBR.

Ms. Miller manages NBR research programs on economic, energy, and trade issues in Asia and guides engagement with Congress as NBR leverages its network of experts to bring objective, detailed analysis of strategic developments in Asia to policymakers. She also leads NBR's media and online outreach programs.

Ms. Miller has experience in both the public and nonprofit sectors. She served at the U.S. Department of State as the Deputy Director for the Office of Economic Policy in the Bureau of East Asia and Pacific Affairs and as an analyst in the Bureau of Intelligence and Research. Prior to joining the State Department, Ms. Miller worked at the U.S.-Vietnam Trade Council on a technical assistance program to support completion of a bilateral trade agreement between the United States and Vietnam as the last step toward full normalization of relations between the two countries.

Ms. Miller holds an MA in International Relations from the Paul H. Nitze School of Advanced International Studies (SAIS) at Johns Hopkins University and a BA in Anthropology from the University of Michigan. She is a specialist in Southeast Asia and speaks Indonesian.

KUNIIHIKO MIYAKE is Research Director at the Canon Institute for Global Studies and a Visiting Professor at Ritsumeikan University. In 2006-7, he was Executive Assistant to Mrs. Akie Abe in the Office of the Prime Minister of Japan. Professor Miyake passed the Foreign Service Officer's (senior class) Exam in 1977 and joined the Ministry of Foreign Affairs (MOFA) in 1978. From 1978-2005, he served in many capacities at MOFA. Most recently, his positions have included: Deputy Director-General of the Middle East Bureau, MOFA; Minister at the Embassy of Japan in Iraq and Japan's Representative to the CPA; Charge d'Affaires at the Embassy of Japan in Iraq; Minister at the Embassy of Japan in China; and Directors of Japan-US. Security Treaty Division, First Middle East Division and Second Middle East Division in MOFA. Mr. Miyake graduated from the Law Faculty of the University of Tokyo.

YU NAGATOMI is Researcher for the Electric Power and Coal Unit of the Electric Power Group at the Institute of Energy Economics, Japan (IEEJ). In his career at IEEJ, Mr. Nagatomi's work has focused on a number of and range of projects, and has included developing models for energy demand forecasting, energy supply optimization, financial and economic analysis, and understanding energy policy and institution. Mr. Nagatomi received his Master's degree from the University of Tokyo.

TOSHIKAZU OKUYA is Director of the Energy Supply and Demand Policy Office of the Agency for Natural Resources and Energy at Japan's Ministry of Economy, Trade, and Industry (METI). In this position, he is in charge of drafting and completing a coming strategic energy plan in Japan. Previously, Mr. Okuya served as Special Advisor to Japan's Ministry of Economy, Trade and Industry at the New York office of the Japan External Trade Office (JETRO). Over the course of his career, Mr. Okuya has covered a range of energy topics, including energy security, geopolitical architecture, and technology innovation.

Mr. Okuya spent part of his career developing science and technology. He was a member of the developing group for Japan's second Science and Technology Basic Plan in 2000, where he was in charge of budget allocation and planning a new higher education system for Japan. He has also been involved in policymaking for Japan's energy sector, including drafting amendment acts on energy supply plans such as the Electricity Business Act, the Gas Business Act, and the Electrical Appliance and Material Safety Act. Mr. Okuya has studied at the John F. Kennedy School of Government at Harvard University.

THE HONORABLE TSUYOSHI SHIINA is Member of the House of Representatives, Japan. In the House of Representatives, Mr. Shiina is affiliated with the Judicial Committee, the Special Committee on Disaster Responce, and the Special Committee on Nuclear Issues. Previously, he served as Researcher for the National Diet of Japan Fukushima Nuclear Accident Independent Investigation Commission. Mr. Shiina's interests include japanese energy security, security policy and political reform in Japan, and the reconstruction from Fukushima Daiichi Nuclear Power Plant Accident. He has a Master of Public Administration from Columbia University, a Master of Public Administration from the London School of Economics and Political Science, and an LLB from the University of Tokyo.

KEI SHIMOGORI is Researcher for the Nuclear Energy Group of the Strategy Research Unit of the Institute of Energy Economics, Japan (IEEJ). Her current research focuses on nuclear power policy and developments in Japan and the world, and on shale gas developments in North America. In her time at IEEJ, she has also written on electricity market reform and nuclear power in the United Kingdom. Ms. Shimogori received her MPP in International Public Policy from the Graduate School of Public Policy at the University of Tokyo and her BL from Waseda University.

NOBUO TANAKA is Global Associate for Energy Security and Sustainability at the Institute of Energy Economics, Japan (IEEJ). As Executive Director of the International Energy Agency (IEA) from 2007 to 2011, he oversaw a seminal period in the Agency's work and direction. Under his leadership, the IEA initiated a collective release of oil stock in June 2011, the third such collective action in the Agency's history, opening new scope and a new era for IEA emergency action. He was responsible for pioneering the concept of "comprehensive energy security" while also expanding the Agency's focus on climate change, renewable energy, and the transition to a low-carbon energy economy. He also played a crucial and personal role in the strengthening of ties with major IEA non-Member energy players, including China, India, Russia, and others.

Mr. Tanaka began his career in 1973 in the Ministry of Economy, Trade and Industry (METI) in Tokyo, and has served in a number of high-ranking positions in METI, including Director-General of the Multilateral Trade System Department. In this capacity, he led many trade negotiations at the World Trade Organization (WTO) and for bilateral Free Trade Agreements. He was deeply engaged in a range of bilateral trade and economic issues with the United States as Minister for Industry, Trade and Energy at the Embassy of Japan, Washington DC from 1998 to 2000, as well serving as the first secretary of the Embassy from 1982 to 1985. With a strong background in international affairs, Mr. Tanaka has served as both Deputy Director and Director for Science, Technology and Industry (DSTI) of the Paris-based Organization for Economic Co-operation and Development (OECD).

TSUTOMU TOICHI is a Senior Advisor for Research at the Institute of Energy Economics Japan (IEEJ). Since joining IEEJ in 1973, he has been engaged in Japan's energy policy making process as an expert member of various governmental committees for many years. He also wrote many books and research papers of which the most recent publication is "Shale Revolution and Japan's Energy Challenge," written in Japanese. Dr. Toichi holds a PhD in geophysics from the Department of Science at the University of Tokyo.

KURT TONG is Deputy Chief of Mission at the United States Embassy in Tokyo since December 2011. Before coming to Tokyo he was the U.S. Ambassador for Asia-Pacific Economic Cooperation (APEC), managing all aspects of U.S. participation in APEC, while concurrently serving as the Economic Coordinator for the State Department's Bureau of East Asian and Pacific Affairs, organizing bureau-wide efforts on economic policy issues.

Mr. Tong has spent 17 years working and studying in East Asia, including service at the U.S. Embassies in Manila, Tokyo (1996-1999), Beijing and Seoul. He was Director for Korean Affairs at the Department of State from 2008 to 2009. Prior to that, he served as Director for Asian Economic Affairs at the National Security Council from 2006 to 2008. He was a Visiting Scholar at the Tokyo University Faculty of Economics from 1995 to 1996. Prior to joining the Foreign Service in 1990, Mr. Tong was an Associate with the Boston Consulting Group in Tokyo.

Mr. Tong holds a BA from the Woodrow Wilson School of Public and International Affairs at Princeton University, and studied graduate-level economics at the U.S. Foreign Service Institute. He has also studied at the Beijing Institute of Education, Inter-University Program for Chinese Language Studies in Taipei, Inter-University Center for Japanese Language Studies in Tokyo, and International Christian University in Tokyo.

Mr. Tong speaks and reads Japanese and Mandarin Chinese. He has published articles in *Nihon Keizai Kenkyu* (an academic journal of the Japan Center for Economic Research) and in *Foreign Policy*. He was born in Ohio and raised in Massachusetts, and enjoys soccer, tennis and other sports. Mr. Tong is married to Dr. Mika Marumoto, and they have three children.

ZHAO HONGTU is Research Professor at the China Institutes of Contemporary International Relations (CICIR). His research interests include energy security, international energy politics, and climate change. He has had visiting fellowships at the Energy Charter Secretariat in Brussels and at the University of Wisconsin-Madison. Dr. Zhao received his PhD in International Relations from East China Normal University.
