**STEWART BECK****Asia Pacific Foundation of Canada**

STEWART BECK is the President and CEO of the Asia Pacific Foundation of Canada (APF Canada). Prior to joining APF Canada, Mr. Beck served as the Canadian High Commissioner to the Republic of India with concurrent accreditation to the Kingdom of Bhutan and to Nepal. He joined the Department of External Affairs and International Trade in 1982 and served abroad in the United States, Taiwan, and the People's Republic of China. In Ottawa, he held a number of positions, including director general of the North Asia Bureau, director general responsible for senior management, and assistant deputy minister for international business development, investment, and innovation. He was also consul general in Shanghai and in San Francisco.

**RICHARD J. ELLINGS****The National Bureau of Asian Research**

RICHARD J. ELLINGS is President of The National Bureau of Asian Research (NBR) and Affiliate Professor of International Studies at the Henry M. Jackson School of International Studies, University of Washington. NBR is a nonprofit, nonpartisan institution whose mission is to inform and strengthen policy in the Asia-Pacific. Co-founder of NBR, he has served as the institution's Executive Director and sits on the Board of Directors.

Prior to serving with NBR, Dr. Ellings was Assistant Director and on the faculty of the Jackson School 1986 to 1989. In this capacity he was a member of the school's Executive Committee and responsible for a wide range of administrative functions. He taught courses dealing with Asia, American foreign policy, and international relations (including foreign economic policy and international political economy), and was director of the George E. Taylor Foreign Affairs Institute.

**CLARA GILLISPIE****The National Bureau of Asian Research**

CLARA GILLISPIE is Director for Trade, Economic, and Energy Affairs at the National Bureau of Asian Research (NBR). In this capacity, Ms. Gillispie leads research, publications, and activities for a range of initiatives,

including the Energy Security Program, the Pacific Energy Summit, and the organization's programming on intellectual property and innovation policy.

Prior to joining NBR in 2011, Ms. Gillispie served as a consultant for Detica Federal Inc., where she conducted program assessments and policy reviews for U.S. government clients. She also interned with both the U.S. House Committee on Science, Space, and Technology and the American Chamber of Commerce in the People's Republic of China. Ms. Gillispie graduated from the London School of Economics and Peking University with a dual MSc in International Affairs.

**SENATOR SLADE GORTON****K&L Gates; Slade Gorton International Policy Center at The National Bureau of Asian Research**

SLADE GORTON serves as Counselor at the National Bureau of Asian Research (NBR) and of counsel at K&L Gates. Senator Gorton represented Washington State for eighteen years in the U.S. Senate. As a senator, he served in many leadership positions, including as counsel to the majority leader (1996–2000).

Senator Gorton was known for his effectiveness on powerful committees, including Appropriations; Energy and Natural Resources; Budget; Commerce, Science, and Transportation; and Intelligence. He chaired the Science, Technology, and Space Appropriations Subcommittee in his first term, the Interior Appropriations Subcommittee (1995–2001), and the Commerce Subcommittees on Consumer Affairs (1995–99) and Aviation (1999–2000). Following his Senate career, Senator Gorton was the first permanent appointment to the 9/11 Commission and also served on the War Powers Commission and the Commission on the Theft of American Intellectual Property.

**ROY D. KAMPHAUSEN****The National Bureau of Asian Research**

ROY D. KAMPHAUSEN is Senior Advisor for Political and Security Affairs at the National Bureau of Asian Research (NBR) and an Adjunct Associate Professor at Columbia University's School of International and Public Affairs. He previously served as Senior Vice President

for Political and Security Affairs and Director of NBR's Washington, D.C., office.

Mr. Kamphausen was Deputy Director of the Commission on the Theft of American Intellectual Property in 2012 and an author of the Commission's report. In addition, he authored an NBR working paper on "New Collaborative Approaches to IP Protection" and has edited the last eight volumes from the annual PLA Conference, published by the U.S. Army War College. Mr. Kamphausen testifies regularly before the U.S. Congress and consults with the U.S. Department of Defense. His analysis appears in major international media, including *Foreign Policy*, the *Financial Times*, the *New York Times*, National Public Radio, and *Newsweek*.

### **PATRICIA KUSZLER** University of Washington School of Law

PATRICIA KUSZLER is the Charles I. Stone Professor of Law and the Vice Dean and Director of the Center for Law in Science and Global Health in the University of Washington School of Law. The center's major components include the JD concentration track in health law and the Health Law LLM program; major collaborations with the University of Washington's Institute for Public Health Genetics, the Northwest Center for Public Health Practice, and the Global Health and Justice Project; a JD/MHA and two JD/MPH concurrent programs; and a variety of grant-funded multidisciplinary research and teaching projects.

Professor Kuszler is the Principal Investigator of the International Biomedical Research Ethics Fellowship Grant and Co-Primary Investigator of the Center for Genomics and Healthcare Equality funded by the National Human Genome Research Institute. In addition to her law faculty appointment, she is an Adjunct Professor in the University of Washington School of Medicine (Department of Bioethics and Humanities) and an Adjunct Professor in the School of Public Health (Department of Health Services).

### **MEREDITH MILLER** The National Bureau of Asian Research

MEREDITH MILLER is Senior Vice President of Trade, Economic, and Energy Affairs and Director of the Washington, D.C., office at the National Bureau of Asian Research (NBR). She manages NBR's research programs on economic, energy, and trade issues to bring objective, detailed analysis of strategic developments in Asia to policymakers.

Ms. Miller has experience in both the public and nonprofit sectors. She served at the U.S. Department of State as the Deputy Director for the Office of Economic Policy in the Bureau of East Asia and Pacific Affairs and as an analyst in the Bureau of Intelligence and Research. Prior to joining the State Department, Ms. Miller worked at the U.S.-Vietnam Trade Council on a technical assistance program to support completion of a bilateral trade agreement between the United States and Vietnam as the last step toward full normalization of relations between the two countries.

Ms. Miller holds an MA in International Relations from the Paul H. Nitze School of Advanced International Studies at Johns Hopkins University and a BA in Anthropology from the University of Michigan. She is a specialist in Southeast Asia and speaks Indonesian.

### **CONGRESSMAN ADAM SMITH** State of Washington

CONGRESSMAN ADAM SMITH is a member of the U.S. House of Representatives and part of the Democratic leadership team. For 18 years, he has fought for issues important to his constituents in Washington's 9th Congressional District.

Following his graduation from Fordham University, Congressman Smith attended the University of Washington School of Law and earned his law degree in 1990. He later worked in both private and public practice, first as a lawyer at Cromwell, Mendoza and Belur in 1992, and then as a prosecutor for the City of Seattle from 1993 to 1995. As a prosecutor, Congressman Smith focused on drunk driving and domestic violence cases, and in 1996, went on to work as a judge pro tempore.

During his final year at the University of Washington, Congressman Smith decided to run for the State Senate in the 33rd Legislative District, where he grew up. When he took office in January 1991, Congressman Smith was 25 years old and the youngest state senator in the country. During his time in the Washington State Senate, he developed a reputation as a moderate Democrat, with a thoughtful and common-sense approach to governance.

Congressman Smith serves as Ranking Member of the House Armed Services Committee, where he is a strong advocate for our military personnel and their families. Having served on the House Armed Services Committee since 1997, he formerly chaired the Subcommittee on Air and Land Forces (ALF), which has jurisdiction over all U.S. Army and nearly all U.S. Air Force acquisition programs. Prior to serving as Chair of ALF, he chaired the Terrorism, Unconventional Threats and Capabilities Subcommittee, which oversees the U.S. Special Operations Forces and counterterrorism policy, among other critical areas. Congressman Smith also previously served on the House Foreign Affairs Committee and the House Permanent Select Committee on Intelligence.

### **TOSHIKO TAKENAKA**

**Center for Advanced Study and Research on Intellectual Property, University of Washington School of Law**

TOSHIKO TAKENAKA is a Washington Research Foundation Simpson Professor of Law in the University of Washington School of Law. She joined the law school faculty in 1993 and teaches patent law, advanced patent law, intellectual property, and intellectual property innovations in science and technology. She is the Co-Director of the Center for Advanced Study and Research on Intellectual Property (CASRIP).

After receiving an LLB from Seikei University, Tokyo, Professor Takenaka pursued a successful career in patent prosecution and management with Texas Instruments Japan Ltd., where she served as a patent prosecution specialist. In 1986, she passed the Japanese Patent Attorney (Benrishi) Bar and worked as an associate for the Yamasaki Law and Patent Office.

Professor Takenaka received her LLM in 1990 and her PhD in Comparative Law in 1992 from the University of Washington School of Law. She was a visiting scholar with the Max Planck Institute for Domestic and International Intellectual Property in Munich, Germany, and a visiting professor at Waseda University in Tokyo, Japan. Professor Takenaka has extensively published in the field of comparative patent law and is a frequent speaker at academic and professional seminars focusing on patent law. She is on the board of editors for the *Journal of Intellectual Property Law & Practice*.

### **PALLAVI MEHTA WAHI** **K&L Gates**

PALLAVI MEHTA WAHI is the Administrative Partner of the Seattle office of K&L Gates. She practices complex commercial litigation with an emphasis on corporate and intellectual property litigation, and serves as a co-chair of the firm-wide India Practice Group.

As an experienced litigator, Ms. Wahi has successfully argued before various tribunals and courts in hearings and at trial.
